to the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,  
extending 10 feet from the location monument in an Easterly  
direction and 1490 feet in a Westerly direction, together with  
300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC  
Pipe monuments firmly set in the ground and bearing applicable monument  
designation. The description of such claim is: Beginning at the Northeast Corner:  
thence, South 600 feet to the Southeast corner,
