### AGREEMENT

THIS AGREEMENT made as of the 26th day of May, 1983,

BETWEEN:

COMINCO LTD., a corporation continued under the Canada Business Corporations Act and having its head office at 2300-200 Granville Street,

Vancouver, British Columbia.

(hereinafter called "Cominco")

AND:

COMINCO AMERICAN INCORPORATED, a Washington corporation, with its principal place of business at West 818 Riverside Avenue, P. O. Box 3087, Spokane, Washington 99220.

(hereinafter called "CAI")

#### WHEREAS:

- A. By virtue of an agreement (the "Assumption Agreement") dated as of the first day of December, 1982, among Bar Resources Limited, Bar Resources Inc., Bethlehem Copper Corporation, Bethex Corporation and Tessik Minerals Ltd. (hereinafter called "Tessik"), a copy of which is attached hereto as Schedule B, Tessik acquired certain mineral property holdings and mining assets located in the United States and a number of shares in the capital of Bar Resources Limited.
- B. The shares of Bar Resources Limited held by Tessik were redeemed and Tessik acquired an additional interest in certain mineral properties located in the United States all as contemplated in the Plan of Arrangement made as of the 18th day of November, 1982, between Bar Resources Limited, Bar Resources Inc., Bethlehem Copper Corporation, Exploration Minerals Ltd. and Pembina Resources Limited.

- CAI accepts that assignment and agrees to be bound by the terms

  lands, mineral property holdings and mining assets being assigned.

3. The Parties acknowledge that certain of those mineral property holdings and mining assets being transferred hereunder may now be held in trust for Cominco in the name of its wholly-owned subsidiary corporation, Bethex Corporation (Bethex). Cominco agrees to cause Bethex to undertake whatever further actions and to execute whatever further documents either Party may deem to be necessary or advisable to consummate the transaction contemplated by this Agreement. The Parties further agree that they each will undertake whatever further actions or execute whatever further documents either Party may deem to be necessary or advisable to consummate the transaction contemplated by this Agreement.


