The claim is 1,500 feet long and 600 feet wide, such that 20 feet are claimed in a SOUTH direction and 1,480 feet are claimed in a NORTH direction from the discovery monument at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the Northerly direction to the Southerly direction.

The definition of the boundaries of the claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by the 30th day of June, 1987.
