CERTIFICATE OF LOCATION
 (LODE)

NOTICE is hereby given that the Rod # 15 lode mining claim has been located by KENNECOTT EXPLORATIONS (AUSTRALIA) LTD., whose office is located at P.O. Box 11248, Salt Lake City, Utah 84147.

By right of discovery, the locator does hereby claim all valuable minerals together with all extralateral variations allowed by law. This claim is 1,500 feet in length and 600 feet in width. The general course of this claim is E-W, and is situated in the unknown Mining District, Eureka County, State of Nevada. This claim runs from the location monument upon which this notice is posted, 1490 feet in a East direction to the East end line, and 10 feet in a West direction to the West end line, together with 300 feet of each side of the center vein.

This claim is monumented by six posts, one at each corner and one at the center of each side line of the claim, taking the form of a rectangle. The claim is situated in the SE quarter of Section 34, Township 36 N, Range 49 E, MDB&M.

The location of this claim in relation to some natural object or permanent monument is as follows: approximately 10,950 feet N 84 E from the SE corner of Sec. 32 T 36 N, R 49 E

The boundaries of this claim can be identified by the following description:

BEGINNING AT THE NE CORNER OF THE CLAIM, ALSO KNOWN AS CORNER NUMBER 1;
 THENCE 600 feet south TO THE SE CORNER, AKA CORNER NO. 2;
 THENCE 750 feet west TO THE S SIDE CORNER, AKA CORNER NO. 3;
 THENCE 750 feet west TO THE SW CORNER, AKA CORNER NO. 4; 3
 THENCE 600 feet north TO THE NW CORNER, AKA CORNER NO. 5; 4
 THENCE 750 feet east TO THE N SIDE CORNER, AKA CORNER NO. 6;
 THENCE 750 feet east TO THE POINT OF BEGINNING.

EXCEPT LOCATION MONUMENT WHICH IS 3" DIAMETER.
 All monuments consist of 4" PVC posts at least 4 1/2 feet in length, and set in a mound of stones where such stones are available. All monuments are marked in permanent manner so as to identify the monuments. The work of location consisted of making a claim map as provided in NRS 517.040.

This claim is contiguous to, and bounded by the following claims: Rod # 13, 16 + 17
