THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2540' S23°W FROM the NE corner Sec 24, TOWNSHIP 24N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NE 1/4 Sec 24 T24N R50E HDM.
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN N2°24'30"W DIRECTION, AND 1480 FEET IN A/AN S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
