FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN N 2° 24' 30" W
DIRECTION, AND 1480 FEET IN A/AN S 2° 24' 30" E DIRECTION,
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600
FEET WIDE AND 1500 FEET LONG.
