AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec 14 & NE 1/4 Sec 23 T24N R 50E MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN N2°24'30"W DIRECTION, AND 1480 FEET IN A/AN S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
