THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1080' S 64.5° E FROM the NW corner of section 19 TOWNSHIP 24 N RANGE 51 E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NW 1/4 Sec 19 T24 R51 E and the NE 1/4 Sec 24 T24 N R50 E MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN N 87° 35' 30" E DIRECTION, AND 1180 FEET IN A/AN S 87° 35' 30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1200 FEET LONG.
