AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec 14 AND SW 1/4 Sec 13 T24 N R50 E MOH. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN S 2° 24' 30" E DIRECTION, AND 1480 FEET IN A/AN N 2° 24' 30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
