THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2300' N725°E FROM the SW corner Sec 13, TOWNSHIP 24N, RANGE S0E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 13 T24 N R50 E MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 100 FEET IN A/AN S2°24'30"E DIRECTION, AND 1400 FEET IN A/AN N2°24'30"W DIRECTION, AND 150' FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 300' FEET WIDE AND 1500 FEET LONG.
