The claim is 1327 feet long and 600 feet wide, and 1317 feet are claimed in a WEST direction and 10 feet in a EAST direction from the location monument, at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the EAST to the WEST.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by SCRIBING ON AN ALUMINUM TAG.

 Corner No. 4 is a 5' LONG, 4" P.C. PIPE SET 1' IN GROUND, MARKED WITH ALUM. TAG NW CORNER
 Corner No. 5 is a 5' LONG, 4" P.C. PIPE SET 1' IN GROUND, MARKED WITH ALUM. TAG NO CORNER
 Corner No. 6 is a 5' LONG, 4" P.C. PIPE SET 1' IN GROUND, MARKED WITH ALUM. TAG NE CORNER

The monumentation and marking of the corners was completed by the 9th day of JULY, 1987. (Must be within 60 days of posting notice of location.)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
