THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2520 Ft. North 88° WEST FROM THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NW+NE 1/4s, Sec. 28, SW+SE 1/4, T10, 21, T23N R50E, MDN. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/N NORTH DIRECTION, AND 1480 FEET IN A/N SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
