AND SAID CLAIM LIES WITHIN THE NE 1/4 JLL 28, SE 1/4 JLL 21, T23N R50E, MDH. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN NORTH DIRECTION, AND 1480 FEET IN A/AN SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
