THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 190 FT. NORTH 33.5° WEST FROM THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NE 1/4 SEC. 28, NW 1/4 SEC. 27, SW 1/4 SEC. 22, SE 1/4 SEC. 21, T23N R50E, MDN. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN NORTH DIRECTION, AND 1480 FEET IN A/AN SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
