THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 490 FT. NORTH 81.5° East FROM THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NW1/4 ALL. 22 SW1/4 ALL. 22 T23N R50E, HDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN NORTH DIRECTION, AND 1480 FEET IN A/AN SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
