AND SAID CLAIM LIES WITHIN THE SW 1/4 ALL. 22 SW 1/4 ALL. 22 T23N R50E, MOH. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN NORTH DIRECTION, AND 1480 FEET IN A/AN SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
