THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1685 FT. North 87.5° East FROM THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NW 1/4 Sec. 27 & NW 1/4 Sec. 22 T23N R50E, 36M. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/N NORTH DIRECTION, AND 1480 FEET IN A/N SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
