THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2885 Ft. North 88.5° East FROM THE NORTHWEST CORNER OF SECTION 28, RANGE 50E, TOWNSHIP 23N, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NW 1/4, 1/4, 27, SW 1/4, 1/4, Section 22, T23N R50E, MDN. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/N NORTH DIRECTION, AND 1480 FEET IN A/N SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
