THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3130 FT. North 87.5° WEST FROM THE NORTHEAST CORNER OF SECTION 28, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE SW 1/4 of Section 21, T23N R50E, HOM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN SOUTH DIRECTION, AND 1480 FEET IN A/AN NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
