SE 1/4 Sec 21 & SW 1/4 Sec 22, T23N R50E, HOM.  
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN SOUTH  
DIRECTION, AND 1480 FEET IN A/AN NORTH DIRECTION,  
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600  
FEET WIDE AND 1500 FEET LONG.
