THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1090 FT. North 84° East FROM THE NORTHEAST CORNER OF SECTION 28, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE SW QUARTER OF SECTION 22, T23N R50E, HOM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN SOUTH DIRECTION, AND 1480 FEET IN A/AN NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
