NW 1/4 SW 1/4 Section 28 T23N R50E 4MDM.
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN North
DIRECTION, AND 1480 FEET IN A/AN South DIRECTION,
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600
FEET WIDE AND 1500 FEET LONG.
