N 88.5° W FROM THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 Sec 28 and SW 1/4 Sec 21, T23N R50E, 36M. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN NORTH DIRECTION, AND 1480 FEET IN A/AN SOUTH DIRECTION, AND 200 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 400 FEET WIDE AND 1500 FEET LONG.
