THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3975' N 89° W FROM THE NORTHWEST CORNER OF SECTION 20, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NW 1/4 Sec 20 and SW 1/4 Sec 21, T23N R50E, 40M. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN NORTH DIRECTION, AND 1480 FEET IN A/AN SOUTH DIRECTION, AND 150 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 300 FEET WIDE AND 1500 FEET LONG.
