THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3630' N88°W FROM THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 23N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 21 T23N R50E, HDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN SOUTH DIRECTION, AND 1480 FEET IN A/AN NORTH DIRECTION, AND 200 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 400 FEET WIDE AND 1500 FEET LONG.
