SW 1/4 Sec 28 T23N R50E, MDH.
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN NORTH
DIRECTION, AND 730 FEET IN A/AN SOUTH DIRECTION,
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600
FEET WIDE AND 750 FEET LONG.
