AND SAID CLAIM LIES WITHIN THE NW & SW 1/4's Sec 21, T23N R50E, 10M. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN South DIRECTION, AND 1480 FEET IN A/AN NORTH DIRECTION, AND 150 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 300 FEET WIDE AND 1500 FEET LONG.
