The discovery monument is located approximately N 13° 00' E 600' from SW CORNER SEC 5 Township 23 N. Range 51 E. Mount Diablo Meridian, NV, and said claim lies within the SW 1/4 SEC 5, SE 1/4 SEC 6, NE 1/4 SEC 7 & NW 1/4 SEC 8 T. 23 N., R. 51 E., MDN. From this discovery monument the undersigned claims 20 feet in a NORTHERLY direction, and 1480 feet in a SOUTHERLY direction, and 300 feet on each side of the middle of the vein. The claim is 600 feet wide and 1500 feet long.

The surface boundaries of the claim are described as beginning at the discovery monument and running thence 20 feet to the center of the NORTH end line and the true point of beginning, thence (clockwise) N 87° 35' 30" E 300 ft. to corner no. 2, thence S 02° 24' 30" E 750 ft. to corner no. 3, thence S 02° 24' 30" E 750 ft. to corner no. 4, thence S 87° 35' 30" W 600 ft. to corner no. 5, thence N 02° 24' 30" W 150 ft. to corner no. 6, thence N 02° 24' 30" W 150 ft. to corner no. 1, thence N 87° 35' 30" 300 ft. to the point of beginning.

There are 7 posts of durable plastic pipe at least 3 inches in diameter by 4 1/2 feet long set 1 foot in the ground, one for the discovery monument, one for each of the four corners and one at the center of each side line as prescribed by N.R.S. Section 517.030.

Location work for this mining claim consisted of preparing and filing a map of said claim as provided in Section 517.040, Nevada Revised Statutes.

This Certificate of Location is hereby made, posted, and recorded to include any and all open ground which may exist as of this date within the boundaries of this lode claim as monumented. All location and discovery work was completed by the 3RD day of MAY, 1987.
