ASARCO Incorporated, whose mailing address of 510 East Plumb Lane, Reno, Nevada 89502 by its undersigned agent, hereby certifies that it has located a mining claim in the UNKNOWN Mining District, County of EUREKA, State of Nevada

Located, dated, and posted on the ground this 7TH day of JUNE, 1987. The name of the claim is WP-118

The general course of said lode or vein as near as it may be described, is NORTH and SOUTH

The discovery monument is located approximately S. 36° 30' W 4850' from SW CORNER SEC. 9 Township 23N Range 50E, Mount Diablo Meridian, NV, and said claim lies within the SW 1/4 SEC. 17 & NE 1/4 SEC. 20 T. 23N. R. 50E, MDM. From this discovery monument the undersigned claims 20 feet in a NORTH direction, and 1480 feet in a SOUTH direction, and 300 feet on each side of the middle of the vein. The claim is 600 feet wide and 1500 feet long.

The surface boundaries of the claim are described as beginning at the discovery monument and running thence 20 feet to the center of the NORTH end line and the true point of beginning, thence (clockwise) EAST 300 ft. to corner no. 2, thence SOUTH 750 ft. to corner no. 3, thence SOUTH 750 ft. to corner no. 4, thence WEST 600 ft. to corner no. 5, thence NORTH 750 ft. to corner no. 6, thence NORTH 750 ft. to corner no. 1, thence EAST 300 ft. to the point of beginning.

There are 7 posts of durable plastic pipe at least 3 inches in diameter by 4 1/2 feet long set 1 foot in the ground, one for the discovery monument, one for each of the four corners and one at the center of each side line as prescribed by N.R.S. Section 517.030.

Location work for this mining claim consisted of preparing and filing a map of said claim as provided in Section 517.040, Nevada Revised Statutes.

This Certificate of Location is hereby made, posted, and recorded to include any and all open ground which may exist as of this date within the boundaries of this lode claim as monumented. All location and discovery work was completed by the 7TH day of JUNE, 1987.
