Summary Report

This report is filed in compliance with the requirements of Title 30 U.S.C. 28-1 for those claims shown on Exhibit "A".

The work consisted of geologic mapping and sampling and an Induced Polarization survey and related activities during the period September, 1986 through August, 1987. The work was done to evaluate the potential for mineral deposits and to assist in further exploration and development work.

The work was performed by Henry W. Ranspot, a geologist with 30 years experience in minerals exploration with a degree from the University of Colorado and Geo Western Geophysical Company of Salt Lake City, Utah.

An exploration program consisting of reverse circulation exploratory drilling is under consideration for this property. All technical data resulting from the program is in the possession of H.W. Ranspot.

Intensely altered zones associated with gold mineralization has been identified on portions of the claim group.
