CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the WI 101A Lode Mining Claim on this 20th day of June, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(NE) (Quarter) Section(s) 3(3), Township 22 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 50 feet in a S 0°56' E direction to Post No. 2, marked - WI 101A - 2
- Thence, 750 feet in a N 89°46' W direction to Post No. 3, marked - WI 101A - 3
- Thence, 750 feet in a N 89°46' W direction to Post No. 4, marked - WI 101A - 4
- Thence, 50 feet in a N 0°56' W direction to Post No. 5, marked - WI 101A - 5
- Thence, 750 feet in a S 89°46' E direction to Post No. 6, marked - WI 101A - 6

the point of beginning and all posts being 3"X4' or 5' durable plastic pipe

The number of linear feet claimed in length along the course of the vein from the point of discovery is 750 feet in a N 89°46' W direction and 750 feet in a S 89°46' E direction, together with 25 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N 89°46' W and S 89°46' E.

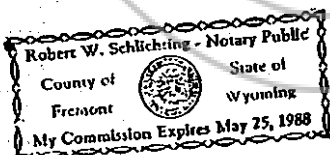
