AMENDED NOTICE AND CERTIFICATE OF LOCATION
(Lode Claim)

Notice is hereby given that American Copper & Nickel Company, Inc., whose mailing address is 4860 Robb Street Suite 201, Wheat Ridge, Colorado 80033, by its undersigned agent, makes this amended location of the Keph #45 lode mining claim in the Unknown Mining District, County of Eureka, State of Nevada.

This Notice is posted upon a location monument on the centerline of the claim. Said claim is located within the NE & NW quarter(s) of Section(s) 6 & 1, T.(s) 22N, R.(s) 49E & 50E, M.D.B. & M., Eureka County, Nevada.

This claim is 1,500 feet in length, running 25 feet in a northerly direction and 1475 feet in a southerly direction from aforesaid location monument, and 600 feet in width (300 feet on each side of the centerline of the claim), forming a claim in the shape of a parallelogram. The general course of said claim is from north to south.

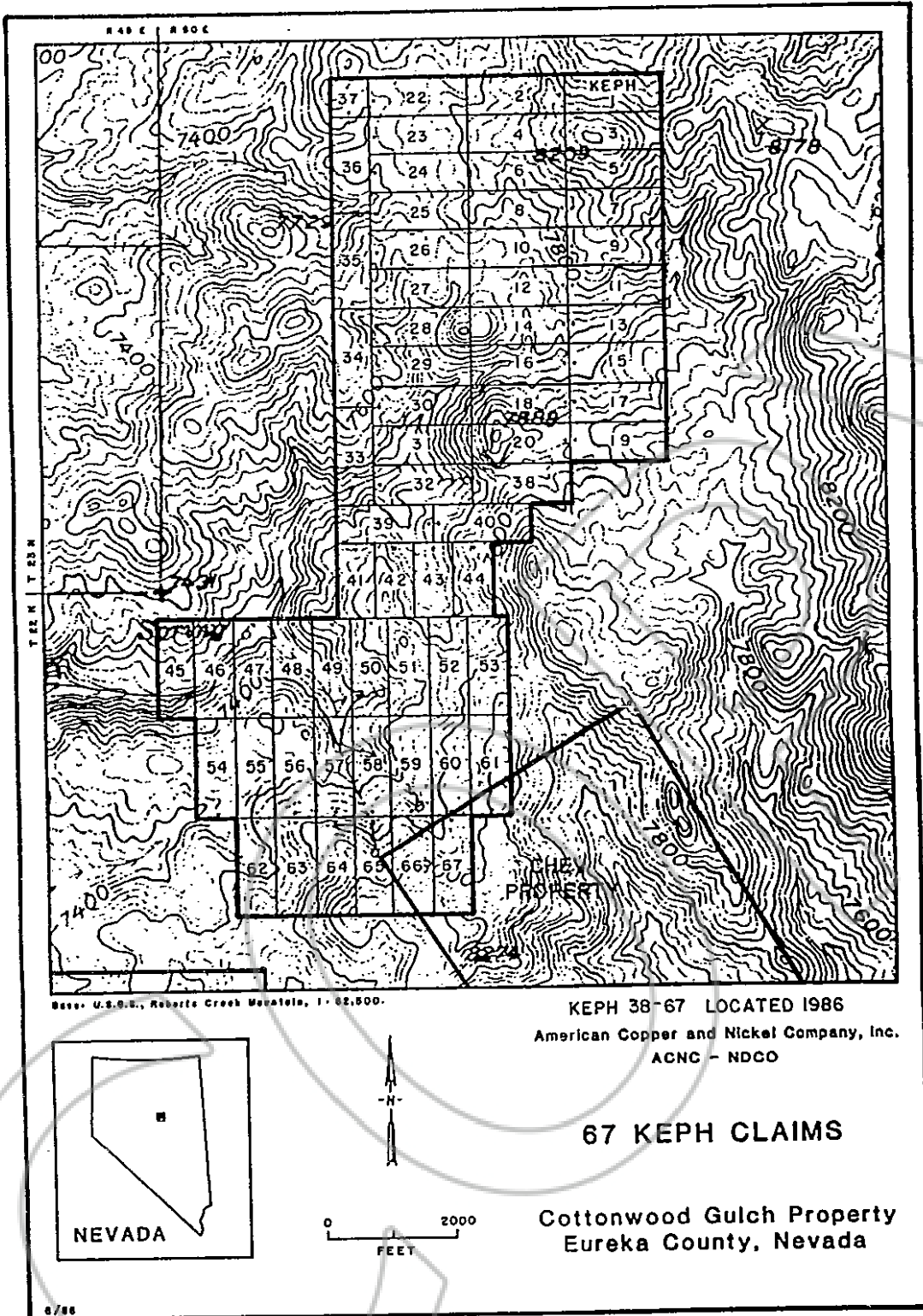
