FURTHERMORE, Hecla does hereby relinquish, release and surrender to Mary M. Bisoni and Geneve Bisoni, their heirs, successors and assigns, all of the interest held by Hecla in that certain Exploration and Mining Agreement with Option to Purchase referred to hereinabove.
