The general course of the lode or vein as near as can be determined is in an Easterly direction from the location monument upon which the Botice of Location is posted. The undersigned claims 1495 feet in an Easterly direction and 5 feet in a Westerly direction from the location monument together with 300 feet on each side of the center of the vein or lode.

Said claim map and description has been simultaneously filed herewith, in the County Recorder's office and the Nevada State BLM office and is by reference incorporated herein.
