The undersigned certifies as follows:

2. That on the 26<sup>th</sup> day of May, 1987, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed, and hereby locates and claims, the lode mining claim called the A No. 26 Mining Claim (the "Claim").
3. The Claim is located in the following quarter sections:
