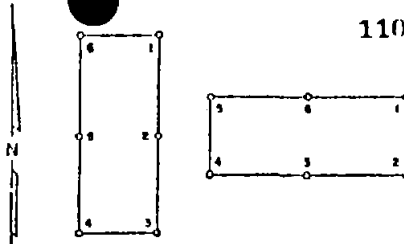

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the MH 38 Lode Mining Claim on this 22nd day of May, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW)(NE)(NW) (Quarter) Section(s) 18(17)(19)(20), Township 18 north, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>750</u> feet in a <u>west</u> direction to Post No. 2, marked - <u>MH 38 - 2</u>
Thence, <u>750</u> feet in a <u>west</u> direction to Post No. 3, marked - <u>MH 38 - 3</u>
Thence, <u>600</u> feet in a <u>south</u> direction to Post No. 4, marked - <u>MH 38 - 4</u>
Thence, <u>750</u> feet in a <u>east</u> direction to Post No. 5, marked - <u>MH 38 - 5</u>
Thence, <u>750</u> feet in a <u>east</u> direction to Post No. 6, marked - <u>MH 38 - 6</u>
Thence, <u>600</u> feet in a <u>north</u> direction to Post No. 1, marked - <u>MH 38 - 1</u>

the point of beginning and all posts being 3" X 4' durable plastic pipe

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.

To tie this Claim to the Public Survey, begin at the SW corner, Section 2, Township 18 N., Range 51 E., Mt. Diablo P.M., and bear east, 17200 feet and south, 10000 feet to the northeast corner of this Claim.
