the point of beginning and all posts being 3" X 4' durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the
point of discovery is 10 feet in a east direction and 1490 feet in a
west direction, together with 300 feet on each side of the center of the
vein or lode for the entire length of the claim.
