# CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the MIL 153 Lode Mining Claim on this 21st day of July, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(NW) (Quarter) Section(s) 32(33), Township 19 north, Range 52 E., Mt. Diablo P.M., and is more particularly described as follows, to wit:
