CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the MH 159 Lode Mining Claim on this 19th day of July, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW) (Quarter) Section(s) 32(33) Township 19 north, Range 52 E., Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>750</u> feet in a <u>west</u> direction to Post No. 2, marked - <u>MH 159 - 2</u>
Thence, <u>750</u> feet in a <u>west</u> direction to Post No. 3, marked - <u>MH 159 - 3</u>
Thence, <u>600</u> feet in a <u>south</u> direction to Post No. 4, marked - <u>MH 159 - 4</u>
Thence, <u>750</u> feet in a <u>east</u> direction to Post No. 5, marked - <u>MH 159 - 5</u>
Thence, <u>750</u> feet in a <u>east</u> direction to Post No. 6, marked - <u>MH 159 - 6</u>
Thence, <u>600</u> feet in a <u>north</u> direction to Post No. 1, marked - <u>MH 159 - 1</u>

the point of beginning and all posts being 3" X 4" durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a east direction and 1490 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.

To tie this Claim to the Public Survey, begin at the SW corner, Section 2, Township 18 N., Range 51 E., Mt. Diablo P.M., and bear east, 21700 feet and north, 6800 feet to the northeast corner of this Claim.

The work of location consisted of making the maps as provided in NRS 517.040. Dated July 28 A.D., 1987, and filed in duplicate.

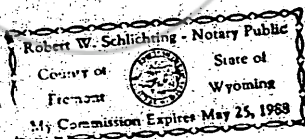
