## DECLARATION AND NOTICE OF CORPORATE SUCCESSION

The undersigned, DANIEL P. WALSH, as Roman Catholic Bishop of the Diocese of Reno-Las Vegas, hereby certifies and declares as follows:

- 1. That the ROMAN CATHOLIC BISHOP OF RENO, AND HIS SUCCESSORS, A CORPORATION SOLE, was duly organized as such by the authority of and in accordance with the laws of the State of Nevada on October 13, 1931, by Thomas Gorman, the then Roman Catholic Bishop of the Diocese of Reno, for the purpose of administering and managing the property and temporalities of the Roman Catholic Church within said Diocese of Reno, and has since continued to be and to act as a corporation sole for such purpose.
- 2. That on or about April 4, 1972, the Articles of Incorporation of such corporation sole were amended to change the name of the corporation sole to "THE ROMAN CATHOLIC BISHOP OF RENO-LAS VEGAS, AND HIS SUCCESSORS, A CORPORATION SOLE".
- 3. That a vacancy in the incumbency of said corporation sole occurred on February 22, 1987, when Norman F.
  McFarland, the then Roman Catholic Bishop of the Diocese of Reno-Las Vegas took canonical possession of another diocese; that thereafter in accordance with the laws, rules and regulations of said Church, Thomas A. Meger, was duly elected as Diocesan Administrator by the College of Consultors, and accepted that election, to act as such successor in said corporation sole and be vested with all the rights and powers

granted by law to such corporation sole until a new Bishop was chosen to take canonical possession of the Diocese of Reno-Las Vegas.

- 4. That the undersigned DANIEL F. WALSH was duly appointed on June 9, 1987, as the Bishop of the Diocese of Reno-Las Vegas by the duly constituted head of said Church, to-wit: His Holiness POPE JOHN PAUL II, and that the undersigned assumed said office in accordance with the laws, rules and regulations of said Church on August 5, 1987; and, thereupon, the undersigned became, ever since has been, and now is, the duly appointed, constituted and acting Bishop of the Diocese of Reno-Las Vegas and as such, the successor in said corporation sole.
- 5. That a true and correct copy of the Decree of Appointment dated July 15, 1987, is annexed hereto as Exhibit "A" and by this reference made a part hereof and incorporated herein; and that a true and correct translation of said Decree, which is in the Latin language, into the English language is annexed hereto as Exhibit "B" and by this reference made a part hereof and incorporated herein.
- 6. That in accordance with the laws, rules and regulations of said Church, the undersigned presented his Decree of Appointment to the College of Consultors of the Diocese of Reno-Las Vegas, that a true and correct copy of the minutes of such meeting is annexed hereto as Exhibit "C" and by this reference made a part hereof and incorporated herein.

7. That the undersigned, as such successor in said corporation sole is, and continuously since August 5, 1987, has been, vested with all the rights and powers granted by law to said corporation sole.

IN WITNESS WHEREOF, the undersigned has executed this instrument on this 11th day of August, 1987, as Bishop of the Diocese of Reno-Las Vegas and as the successor in said corporation sole, and gives notice of the foregoing to all to whom it may concern.



### DECREE

Although the Apostolic Letters have been prepared by which the Most Reverend Daniel F. Walsh is transferred from the Titular See of Tigia to the Residential See of Reno-Las Vegas, they have not yet been received. His Holiness, POPE JOHN PAUL II, through the Congregation for Bishops, has graciously granted that notwithstanding the lack of the aforesaid Apostolic Letters, the Most Reverend Daniel F. Walsh, having taken the Oath of Fidelity, may validly and licitly take canonical possession of the See of Reno-Las Vegas, since this is preferable for the good of the clergy and the faithful, all other things being maintained which are required by law.

All things to the contrary notwithstanding.

In testimony of which, I have issued the present Decree, signed by my own hand and sealed with our own seal.

Given at Washington, at the Apostolic Nunciature, on the fifteenth day of July, in the Year of Our Lord nineteen hundred and eighty-seven.
