The number of linear feet claimed in length along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is:

1480 feet west erly, and 20 feet east erly, which is the general course of the lode or vein as near may be, and on the north erly side of the center of the vein 300 feet is claimed, and on the south erly side of the center of the vein 300 feet is claimed.

At each corner of the claim and at the center of each sideline, there is a monument in compliance with N.R.S. 517.030, so marked as to designate the claim name and corner number.

The claim and its corners are more particularly described as follows:

From Corner No. 1, also known as NE corner of this claim, the SE corner of Section 36, T. 26N, R. S2 East of the Mt. Diablo P. M., if such corner exists, or a claim location marker constructed as specified in N.R.S. 517.040, if such corner does not exist, bears:

South a distance of 8200 feet, thence East a distance of 8000 feet.

Beginning at Corner No. 1, thence southerly a distance of 600 feet to Corner No. 2, thence west erly a distance of 1500 feet to Corner No. 3, thence northerly a distance of 600 feet to Corner No. 4, thence east erly a distance of 1500 feet to Corner No. 1, the place of beginning.

The north erly side center monument lies midway between corners 1 and 4, and

the south erly side center monument lies midway between corners 2 and 3.
