Beginning at Corner No. 1, thence south early a distance of 600 feet to Corner No. 2, thence west early a distance of 1500 feet to Corner No. 3, thence north early a distance of 600 feet to Corner No. 4, thence east early a distance of 1500 feet to Corner No. 1, the place of beginning.

The north early side center monument lies midway between corners 1 and 4, and the south early side center monument lies midway between corners 2 and 3.
