The number of linear feet claimed in length along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is:

1480 feet westerly, and 20 feet easterly, which is the general course of the lode or vein as near may be, and on the northerly side of the center of the vein 300 feet is claimed, and on the southerly side of the center of the vein 300 feet is claimed.

At each corner of the claim and at the center of each sideline, there is a monument in compliance with N.R.S. 517.030, so marked as to designate the claim name and corner number.

The claim and its corners are more particularly described as follows:

From Corner No. 1, also known as NE corner of this claim, the SE corner of Section 36, T. 26N, R. 52 East of the Mt. Diablo P.M., if such corner exists, or a claim location marker constructed as specified in N.R.S. 517.040, if such corner does not exist, bears South a distance of 8200 feet, thence East a distance of 9500 feet.

Beginning at Corner No. 1, thence southerly a distance of 600 feet to Corner No. 2, thence westerly a distance of 1500 feet to Corner No. 3, thence northerly a distance of 600 feet to Corner No. 4, thence easterly a distance of 1500 feet to Corner No. 1, the place of beginning.

The northerly side center monument lies midway between corners 1 and 4, and the southerly side center monument lies midway between corners 2 and 3.
