1480 feet westerly, and 20 feet easterly, which is the general course of the lode or vein as near may be, and on the north easterly side of the center of the vein 300 feet is claimed, and on the south easterly side of the center of the vein 300 feet is claimed.

At each corner of the claim and at the center of each sideline, there is a monument in compliance with N.R.S. 517.030, so marked as to designate the claim name and corner number.

The claim and its corners are more particularly described as follows:

From Corner No. 1, also known as NE corner of this claim, the SE corner of Section 36, T. 26N, R. 52 East of the Mt. Diablo P. M., if such corner exists, or a claim location marker constructed as specified in N.R.S. 517.040, if such corner does not exist, bears South a distance of 4600 feet, thence East a distance of 9500 feet.

Beginning at Corner No. 1, thence south easterly a distance of 100 feet to Corner No. 2, thence westerly a distance of 1500 feet to Corner No. 3, thence north easterly a distance of 600 feet to Corner No. 4, thence easterly a distance of 1500 feet to Corner No. 1, the place of beginning.

The north easterly side center monument lies midway between corners 1 and 4 and the south easterly side center monument lies midway between corners 2 and 3.
