

Certificate of Location of Lode Mining Claim

Said claim is located in the NE+NW Quarter, Section(s) 1 Township 27N, Range 48E, Mount Diablo P.M.

The claim is 1500 feet long and 600 feet wide, and 20 feet is claimed in a East direction and 1480 feet in a West direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by An Aluminum Tag.

To tie this Claim to the Public Survey, begin at the Northwest corner, Section 36, Township 28N, Range 48E, Mount Diablo P.M., bear South 7350 feet, and East 2550 feet to the northeast corner of this claim.

The description of each corner is as follows:

Corner No. 1 is a PVC Pipe, 3 inches in diameter
Corner No. 2 is a PVC Pipe, 3 inches in diameter
Corner No. 3 is a PVC Pipe, 3 inches in diameter
Corner No. 4 is a PVC Pipe, 3 inches in diameter
Corner No. 5 is a PVC Pipe, 3 inches in diameter
Corner No. 6 is a PVC Pipe, 3 inches in diameter

The monumentation and marking of the corners was completed by the 4th day of August, 1987
(Must be within 60 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
