The claim is 1500 feet long and 600 feet wide, and 1450 feet is claimed in a East direction and 30 feet in a West direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

Corner No. 6 is a PVC Pipe, 3 inches in diameter

The monumentation and marking of the corners was completed by the 4th day of August, 1987.
