MEMORANDUM OF MINING EXPLORATION AND LEASE AGREEMENT

This Memorandum of Mining Exploration and Lease Agreement ("Memorandum") made and entered into by and between EDWARD L. DEVENYNS and DAVID R. ERNST, hereinafter collectively referred to as "Lessor", and HYCROFT RESOURCES & DEVELOPMENT, INC., a Nevada corporation, hereinafter referred to as "Hycroft".

The execution and recording of this Memorandum shall not limit, increase or in any manner affect any of the terms of the Agreement, or the rights, interests or obligations of Lessor and Hycroft thereunder.
