The claim is 1,500 feet long and 600 feet wide, such that 20 feet are claimed in a Westerly direction and 1,480 feet are claimed in a Easterly direction from the discovery monument at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the Easterly direction to the Westerly direction.

The definition of the boundaries of the claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed within 60 days of location.
