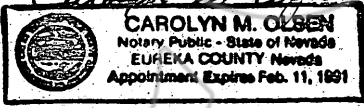

Report on Geochemical Survey for Claims
Grimm 1 thru Grimm 56

A geochemical survey of the above listed unpatented mining claims was conducted from April 1987 to August 1987. Soil samples were taken from the eastern portion of the claim group encompassing an area of 6000 feet by 4000 feet. Samples were taken on 200 foot intervals along north-south traverses 400 feet apart. All samples were assayed for gold by Chemex Labs Ltd. in Vancouver, B.C.

The results of this survey show small localized anomalous areas in:

- the southern portion of Grimm 45 and northern portion of Grimm 46
- the southern portion of Grimm 41 and northern portion of Grimm 42

This survey was non-repetitive of any previously known work, and did benefit the exploration and development of each claim in this group.

The work was carried out by Anne E. Pate, a qualified expert in the field of mining and exploration for 11 years.
