

## ROYALTY ASSIGNMENT

This assignment made and entered into this 12 day of August, 1987, by and between Gerald L. Tawney, and his wife Hazel D. Nielsen, P.O. Box H, Goleta, California 93116, herein referred to as assignor, and Spiro G. Vassilopoulos, 909 Rio Vista Circle SW, Albuquerque, New Mexico 87105, hereinafter referred to as assignee.

## WITNESSETH:

The undersigned assignor for and in consideration of the sum of \$10.00 and other good and valuable considerations to assignor in hand paid by said assignee, the receipt of which is hereby confessed and acknowledged, does hereby sell, assign, transfer, set over, and convey unto said assignee, heirs, personal representatives and assigns, an overriding royalty equal to FIVE PERCENT OF EIGHT-EIGHTHS (5.0% of 8/8ths) of the market value at the wells as provided of all the oil and gas and other hydrocarbon substances which may be produced, saved and marketed from the following described lands situated in the County of Eureka, State of Nevada to-wit:

Township 28 North, Range 51 East, MDM  
 Section 2: LOTS 1,2,3,4, S1/2N1/2, S1/2 (ALL)  
 Section 29: ALL  
 Section 31: LOTS 1,2,3,4, E1/2W1/2, E1/2 (ALL)  
 Section 32: All

Containing a total of approximately 2503.96 acres

under the terms of that certain oil and gas lease made and entered into by and between the United States of America as lessor, and Gerald L. Tawney as lessee, bearing No. N-42862, or any extension or renewal thereof; said overriding royalty shall be computed and paid at the same time and in the same manner as royalties payable to the United States of America under the terms of said lease are computed and paid, and assignee shall be responsible for assignee's proportionate part of all taxes and assessments levied upon or against or measured by the oil and gas from said land.

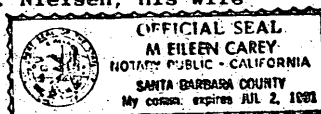
